Thank you for your request of 7 May, received via Twitter, for the following information under the Official Information Act:

How often do @ClimateCommNZ staff fly? Why? Was an assessment mode on whether zoom was a practical alternative?

The Commission sought confirmation of the cope of your request on 10 May 2021 and following your response, it was agreed your request seeks the following information:

- A list of staff flights,
- The reasoning/rationale for those staff flights, and
- What assessment was undertaken regarding whether alternatives to travel were considered.

Attached is a spreadsheet listing all flights taken by Commission staff and Board members in the year preceeding your request. We have also included flights for consultants that the Commission paid for and booked. Please note, all flights listed in the spreadsheet were paid for and booked by the Commission through its travel provider, Tandem Travel. Tandem does not record the reason for travel. Therefore, this information has subsequently been coded in for each flight by the Commission.

Please note, in two instances, consultants invoiced the Commission for air travel expenses incurred as part of their work with us. Details of these flights do not appear in the spreadsheet. They can be found in the table below.

Air travel and alternatives

The Commission's travel policy looks to minimise Commission travel and its environmental impact. Where appropriate and available, meetings and day-to-day operations of the Commission are held by videoconference. That said, there are instances where travel is required. In these instances, the Commission's preference is for low-emissions transport options. When feasible these options were used.

In the period covered by your request, air travel was primarily used to allow Commission staff and Board members to engage and consult with a wide range of stakeholders. These engagements included face-to-





face relationship building and collaborative consultations with key stakeholders and the larger New Zealand public during the Commission's establishment phase and around the Commission's draft Advice 21 package.
